- **Joint venture /consortium of parties** is acceptable for this Tender cum Auction bid with an MOU in Non-Judicial stamp paper should be submitted declaring the consortium and accepting responsibilities and liabilities severally and jointly.

The bidders are requested to submit EMD and cost of the Tender cum Auction bid document along-with the attested copies of valid Pan-Card and FSSAI Certificate details along-with the bid documents, failing which the Tender cum Auction bid shall be declared as non-responsive and thus liable for rejection.

TERMS OF REFERENCE FOR
LEASING OF FRY FISH STALL IN ALIYAR AT
COIMBATORE DISTRICT
(FOR A PERIOD OF THREE YEARS)

1. Tender cum Auction bid Components:

This Tender cum Auction bids are invited from the firms / Tender cum Auction bidders for the Leasing of Fish fry stall of TNFDC Ltd, at Aliyar in Coimbatore. The period of lease would be for a period of 3 years with 10% increase in the annual lease amount for the subsequent years.

2. Objectives:

The objectives of the tenderer for operation of the Fish fry stall of TNFDC Ltd, at Aliyar in Coimbatore district are listed below:

- The Tender cum Auction bidder is required to Operate & Maintain the Fish fry stall at Aliyar in Coimbatore on Lease basis with TNFDC Ltd., on agreement terms and conditions.
- Regular up keep and manage the infrastructure of the Fish fry stall and buildings along with its related activities at Aliyar.
- The bidding parameter to the eligible Tender cum Auction bidder is quote of annual lease amount exclusive of GST applicable.

3. Scope of Work:

The various scope of the works (but not limited to) for the Tender cum Auction bidder contractor are listed below:

- a. The successful Tender cum Auction bidder is required to operate and maintain the Fish fry stall.
- b. The Tender cum Auction bidder should cater for menu in the Fish fry stall.
- c. The Tender cum Auction bidder should maintain hygiene and taste standard all times
- d. Maintain all accounting and statutory records as required by the Corporation apart from obtaining all required licenses, clearances from local bodies etc.,

4. Terms of Reference:

- a. The electricity consumption charges are to be paid by the successful Tender cum Auction bidder based on sub meter provided every month to TNFDC Ltd., as per claim without fail.
- b. No major modifications are permitted to the provided infrastructural facilities by the Tender cum Auction bidder without permission of the TNFDC Ltd.,

- c. The Tender cum Auction bidder should fulfill all statutory requirements like permissions, FSSAI clearances, licenses etc. and take all required permission for operation of Fish fry stall at Aliyar from the authorities concerned.
- d. The Tender cum Auction bidder / operator will be handed over Fish fry stall in “as is where is” conditions. The operator will operate and maintain the facility by employing qualified staff at their cost.
- e. The period of lease will be for 3 (three) years.
- f. The quoted amount will be for annual basis excluding all taxes and charges (GST) applicable as per norms.
- g. Notice period for termination from either side is 90 (ninety) days after a minimum of 9 (nine) months operation.
- h. No liquor will be permitted to sale in the Fish fry stall.
- i. The Taxes & Charges if any livable by the local bodies/authorities concerned are to be taken by the Fish fry stall operator only.
- j. The Fish fry stall given to be handed over to TNFDC in good conditions at the end of contract period.
- k. The Fish fry stall should be used only for lawful activities & in accordance to the rules & regulation enforced by the Government authorities.
- l. The facilities are leased out in as is where is conditions hence Tender cum Auction bidders are requested to inspect the facilities before quote.
- m. All licenses, clearances required for stall should be obtained from all local bodies, Government department by the lessee.

4. Mode of Operation of Restaurant:

- i. The Fish fry stall should be operated in the name of the TNFDC Ltd & Brand –Logo of TNFDC Ltd in full sprit.
- ii. All the staff & personnel of Fish fry stall should be engaged by the Tender cum Auction bidder at his cost.
- iii. Sale billing should be in transparent manner to both TNFDC & the Fish fry stall operator.
- iv. The preference should be given for fish food recipes in the menu & pricing pattern should be done with mutual consent only.
- v. Scope of Co-branding may also be explored on mutual consent.

6. Period of Contract:

The period of contract for operation and maintenance of Fish fry stall at Aliyar, Coimbatore would be three years with 10% increase on 1st year Tender cum Auction bid Amount and for subsequently years i.e., upto 3 years

GENERAL CONDITIONS OF TENDER CUM AUCTION BID

1. All Tender cum Auction bids must be addressed to The Managing Director, TNFDC Ltd., Integrated Office Complex for Animal Husbandry & Fisheries department, No.571, 4th Floor, Anna salai, Nandhanam, Chennai-600 035 and must reach this office not later than 3.00 p.m on 17.08.2026 in a Sealed cover duly SUBSCRIBED TENDER CUM AUCTION BID FOR OPERATION & MAINTENANCE OF THE FISH FRY STALL AT ALIYAR in COIMBATORE . Tender cum Auction bid received after 3.00 p.m on the same day will be returned to the Tender cum Auction bidder unopened. Tender cum Auction bidders may be present if they so desire at the time of opening Tender cum Auction bids.
2. Tender cum Auction bids shall be submitted either by Registered post, courier with acknowledgment due or in person. Tender cum Auction bids by telegram or by any other means of communications will not be accepted.
3. Tender cum Auction bids shall be submitted in the Sealed cover only, failing which they will not be considered. The pre Qualification bid for leasing of Fish fry stall at Aliyar in Coimbatore district will be conducted by the Committee of TNFDC Ltd., at 3.30 pm on 17.08.2026 at the Tamil Nadu Fisheries Development Corporation Limited, Integrated Office Complex for Animal Husbandry and Fisheries Department, No.571 4th Floor, Anna salai, Nandanam, Chennai- 600 035. After the evaluation of Pre Qualification Bids, qualified bidders will be informed of the time, venue and date of opening of financial bid and auction.
4. The auctioning committee authorized by the Managing Director, TNFDC will evaluate the pre qualification bid and conduct the auction-cum-tender. The auction will be carried out initially and then sealed tenders will be opened. On conclusion of auction bids round, sealed tenders will be opened and if the tendered amount is higher than the highest auction bid, there will be a second auction only with the H1 auction bidder and wit H1 tenderer. Decision of the auctioning committee is final as regards to the finalization of pre qualification.
5. (a) Tender cum Auction bids by firm shall be in the firm's name signed on behalf of the firm by the person authorized in this behalf. In case of partnership firm, the names of all the partners with their full postal address should be furnished with the Tender cum Auction bid and if the firm is registered under the Indian Partnership Act of 1931 the registration Number of the firm should also be given. The partner who is signing a Tender cum Auction bid form should hold a power of Attorney in his favor to act for and on behalf of the partnership of firm. In case of a joint Hindu Family the Tender cum Auction bid must be signed by the Manager.
6. (a) The Tender cum Auction bid amount should be legibly written in INK BOTH IN FIGURES AND WORDS.
(b) Tender cum Auction bids containing erasures or alterations without proper Attestation/Omissions are liable to be rejected.
(c) Tender cum Auction bid amount should be Paid immediately after acceptance of Tender cum Auction bid. 2nd year lease amount should be paid with 10% increase on 1st year Tender cum Auction bid Amount and for subsequent year of lease upto 3 years.
7. (a) The Envelope for the Earnest money shall be superscripted with "Earnest Money" and shall contain EMD of Rs.25,000/- by means of DD, obtained from nationalized / scheduled bank located in India favoring " The Managing Director, TNFDC Ltd." payable at Chennai to keep the offer open till

acceptance/ rejection thereof is communicated by the TNFDC Administration or till 120 days (One hundred and twenty days) from the date of opening the Tender cum Auction bid whichever is earlier. The EMD should be valid for 45 days beyond the validity of the Tender cum Auction bid. Offers received without earnest money shall be summarily rejected.

(b) It shall be understood that the Tender cum Auction bid documents have been sold/issued to the Tender cum Auction bidder. The Tender cum Auction bidder is permitted to submit the Tender cum Auction bid in consideration of the stipulation on his part that after submission of his Tender cum Auction bid, will not renege from or modify the terms and conditions thereof in a manner not acceptable to the TNFDC Administration. Should the Tender cum Auction bidder fail to observe or comply with the said stipulation, the aforesaid amount shall be liable to be forfeited by the TNFDC.

No interest will be allowed on the Earnest Money Deposit. Tender cum Auction bids will not be considered unless the Earnest Money Deposit, have been deposited in accordance with the stipulations of this para.

8. The Earnest Money Deposit deposited by the successful Tender cum Auction bidder will be adjusted towards Security deposit payable by them before entering into acceptance subject to the conditions stipulated above. The earnest Money Deposit of the unsuccessful Tender cum Auction bids will be returned /refunded as soon as the Tender cum Auction bids have been disposed off.
9. Each Tender cum Auction bid must be accompanied with the following: -
 - a. The remittance of Earnest Money Deposit & Tender cum Auction bid cost.
 - b. In case of a Partnership Firm, the copy of the certificate of registration issued by the Competent Authority.
 - c. The copy of the power of Attorney of the Managing Partner to sign the Tender cum Auction bid document should also be enclosed with the Tender cum Auction bid
10. Tender cum Auction bids submitted without proper and fully complying with Tender cum Auction bid requirement will be disqualified and will not be considered.
11. The Successful Tender cum Auction bidder shall be required to execute an agreement in the prescribed form failing which he will not be considered.
12. (i) The successful Tender cum Auction bidder must deposit to the TNFDC Administration in advance at the time of initial award of the contract a sum equivalent to 25% of the contract value as Security deposit within 14 days of the date of acceptance and communication of the award of tender and execute an agreement in the prescribed form

(ii) The successful applicant shall remit security deposit in the form of Demand Draft being 25% of the contract value which will be veils and kept open not only during the contract period of three years but also for a further period of six months beyond the contract period and take up the contract within 14 days of the date of acceptance of Tender cum Auction bid award.
13. Should a Tender cum Auction bidder whose Tender cum Auction bid has been accepted and communicated , if decline or failed to remit the 25% towards security deposit as referred above and also execute an Agreement in the prescribed form and take up the contract within 14 days from the date of

acceptance of Tender cum Auction bid, the Earnest Money Deposit will be forfeited by the TNFDC administration as ascertained liquidated damages.

14. The contractor or his Agent must be available at the Fish fry stall at Aliyar in Coimbatore for all working hours or such period as may be specified from time to time by any authorized official of TNFDC Ltd.
15. The successful Tender cum Auction bidder shall not assign, sublet or transfer the contract either on whole or part. If it is found that the contract has been assigned or sublet or either in part or in full, the TNFDC Administration will terminate the contract without any notice duly forfeiting the Security as ascertained liquidated damages.
16. No separate communication related to the 'Tender cum Auction bid' should be addressed by the Tender cum Auction bidder to the officer or any other person in the TNFDC Administration. All explanatory or qualifying remarks which the Tender cum Auction bidder may desire to make should be recorded in the Tender cum Auction bid form in the space provided for the purpose in the respective paras.
17. Further the TNFDC Administration reserves the right to accept/negotiate with the next second highest Tender cum Auction bidder in the event the highest Tender cum Auction bidder withdraws the bid or not able to abide by the terms and conditions of the contract.
18. The Fish fry stall shall be operated in the name of TNFDC Ltd & Brand logo of TNFDC Ltd to be indicated in the name board without fail.
19. The Tender cum Auction bidder shall utilize the space only for the purpose of Fish fry stall apart from the scope of lease provided in the Tender cum Auction bid document. The Fish fry stall should be strictly operated in Hygienic manner by adopting the existing standards and guidelines meant for food safety as published by Governments.
20. The successful bidder has to procure a minimum of 2 ton of fishes per month from the Manager Coimbatore Marketing Unit. The Fishes will be sold to the successful bidder by adding transport cost, Icing charges and with a margin of 10% to the actual rate of the fish. i.e., reservoir rate of fishes which have been caught in TNFDC controlled reservoirs. In the case of fishes (Marine and Inland Fishes) bought from wholesale market, the rate will be fixed by adding the above charges and 10% profit margin.
21. All permits / licenses / permission for the Fish fry stall have to be obtained by the Tender cum Auction bidder only at his cost & name and risk from the appropriate authorities by following the procedures.
22. All sanctions, permissions no objections, letters of intent, consent licenses, clearance, approvals etc. shall be obtained by the Tender cum Auction bidder at his cost and such as document shall be kept effective and in force at all material times.
23. The building, furniture and other machineries licensed shall have insured against fire, rioting and other possible losses and the insurance policy be taken and the insurance premium be borne by the Tender cum Auction bidder. Tender cum Auction bidder should pay the compensation to the public or their relatives if any accident happens at their own cost if they claimed.
24. The TNFDC Ltd. shall have the right to inspect the premises and also the books of accounts, etc. at any time.

25. The Tender cum Auction bidder shall not encumber the licensed properties by way of pledge, hypothecation, mortgage, charge, lien, lease, leave and license or in any other manner.
26. The Tender cum Auction bidder has to confine his activities only within the specified area handed over to him.
27. No political meeting shall be allowed within the premises, which has been allotted to him.
28. No unlawful activities like betting, gambling, etc. shall be allowed inside the campus.
29. Anti Government activities shall not be allowed inside the premises / place allotted to them.
30. In case the Tender cum Auction bidder commits breach of any of the terms and conditions and stipulation herein contained on the part of the Tender cum Auction bidder to be observed and performed, then in such cases the TNFDC Ltd. shall be at liberty to give a notice in writing (by RPAD) to the licensee to set right or rectify the breach or omission of any of the terms, conditions and stipulations of the agreement and in case of non compliance on the part of Tender cum Auction bidder within 30 days of the receipt of such notice, this agreement at the option of the licensor may be terminated and upon such termination this agreement shall become null and void and all the rights of the Tender cum Auction bidder herein shall immediately cease and determine. The agreement may also be terminated for any criminal acts on the part of the Tender cum Auction bidder which need not be referred to arbitration.
31. The TNFDC Ltd. shall have the right to take over the operation and terminate the license agreement, in case of default or any type of malpractice noticed on the part of the Tender cum Auction bidder.
32. The TNFDC Ltd. will not be vicariously liable for any act of the Tender cum Auction bidder and the Tender cum Auction bidder shall alone be liable for violation of any law and the Tender cum Auction bidder agrees to indemnify the TNFDC Ltd. from all claims.
33. All costs, charges, including stamp duty and registration charges, etc. shall be borne by the Tender cum Auction bidder.
34. The Tender cum Auction bidder shall ensure due observance, compliance with all relevant laws, rules and regulation applicable to business from time to time.
35. If any loss or damage is caused to properties either by Tender cum Auction bidder or suppliers and servants either willfully / in advertently the cost / extent of loss / damage will be recovered from the Tender cum Auction bidder.
36. On the expiry of the license, the Tender cum Auction bidder shall handover all articles which were entrusted in good conditions.
37. The Tender cum Auction bidder shall insure his staff, property, guests, etc. at his cost and risk.

38. The Tender cum Auction bidder has to provide Photo Identity Cards to the persons employed by him/her for carrying out the work. These cards are to be constantly displayed & their loss reported immediately.
39. The transportation, food, medical and other statutory requirements in respect of each personnel of the Tender cum Auction bidder shall be the responsibility of the Tender cum Auction bidder.
40. The Tender cum Auction bidder shall have employer's liability and workers' compensation insurance in respect of the Personnel of the Tender cum Auction bidder and of any sub-contractors, in accordance with the relevant provisions of the Applicable law, as well as, with respect to such personnel, any such life, health, accident, travel or other insurance as may be appropriate; and
41. The Tender cum Auction bidder shall be contactable at all times and messages sent by phone /e-mail/ fax / special messenger from this office shall be acknowledged immediately on receipt on the same day. The Tender cum Auction bidder shall strictly observe the instructions issued by TNFD Corporation in fulfillment of the contract from time to time.
42. This office shall not be liable for any loss, damage, theft, burglary or robbery of any personal belongings, equipment or vehicles of the personnel of the Tender cum Auction bidder.
43. The successful Tender cum Auction bidder shall furnish a security deposit equivalent to 25% of the contract value by means of demand draft drawn in favour of the TNFDC from a nationalized / commercial bank in an acceptable form safeguarding the interest of this office in all respects. The security deposit shall remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the Tender cum Auction bidder. The security deposit will be forfeited in case of the non-compliance of the terms of agreement by the Tender cum Auction bidder or frequent absence from duty/misconduct.
44. The successful Tender cum Auction bidder will enter into an agreement with this office as per the terms and conditions on non judicial Rs. 100/- stamp paper. The above stamp paper will be arranged by the bidder for execution of agreement. The agreement will be valid for a period of three years commencing from, and shall continue to be in force in the same manner, unless terminated in writing.
45. The lease amount quoted by the Tender cum Auction bidder shall be on annual basis with increase at 10% every year for a period of three years and no request for any change/modification shall be entertained before expiry of the period of three years. The contract/agreement is extendable by another three years subject to satisfactory performance of the Tender cum Auction bidder and as mutually agreed to.
46. The agreement can be terminated by either party by giving one month's notice in advance. If the Tender cum Auction bidder fails to give one month's notice in writing for termination of the Agreement etc and any amount due to the Tender cum Auction bidder from the office shall be forfeited.

47. This office reserves the right to reject any or all the Tender cum Auction bids without assigning any reason whatsoever and the decision of the management shall be final and binding on all the bidders.
48. The Managing Director, TNFDC as the competent authority reserves the right to cancel the lease without assigning any reasons therefore.
49. For breach of any of these conditions TNFDC has full rights to take penal action as deemed fit against the bidder.
50. Any money due by the contractor under the terms of the Tender cum Auction bid shall be recovered by the appropriate statutory act or any modifications thereof.
51. In case of any dispute, the court of legal jurisdiction shall be civil court of the relevant jurisdiction.

3.
